Justice Issues Assault Warrant for Rudy Vallee

MIAMI, Fla.—(INS)—A warrant for the arrest of Rudy Vallee, radio entertainer, charging him with assault and battery was issued here Friday by Peace Justice Thomas E. Ferguson. The warrant was issued on complaint of Dillard Borden, bus boy at the Royal Palm night club, who charged that last Tuesday night he bumped into Vallee while carrying a tray of dishes and that Vallee beat him for it.

Farm Lumbering Ruled Exempt from Wage Law

WASHINGTON—(INS)—The wage-hour administration Friday clarified the coverage of the fair labor standards act as it applies to forestry or lumbering operations performed by farmers. It stated that persons employed in agriculture, "which includes exempting in all its branches, are exempt from both the wage and hour provisions of the act and such practices as forestry or lumbering carried on as an incident to farming are also covered by this exemption." It added: "The agricultural exemption, however, would seem to include forestry or lumbering operations only when they constitute a subordinate and established part of the farming activities."

U. S. Court Fines Two State Firms for False Labels

Two Wisconsin concerns were fined in federal court here Friday for shipping misbranded merchandise in interstate commerce. Judge Patrick T. Stone assessed the Willson Monarch Laboratory, Edgerton, \$10 on each of 11 counts for improperly labeling medicines and other products. The Columbus Food co., Columbus, was fined \$25 for shipping canned field corn labeled as sweet corn.

Ileana, of 'Old Russia, Orates Self Into Jail

HOLLYWOOD—(INS)—Ileana Laurel, temptuous wife of the shy comedian, Stan Laurel, tapped an impatient foot and hummed Russian songs in the county jail today. The Russian songs were of the old regime, and distinctly not filled with patriotism for Communist Russia. She was taken into custody Thursday night when her distaste for the present regime became so strong, police said, that Ileana began an oration in a night club and annoyed other guests. The blonde and shapely Ileana was booked on suspicion of intoxication.

Smathers never uttered the sentence. Barkley begged him to cut it out. For harmony's sake, he consented.


Immunity baffled 'em

The young ladies tried to send the cops off with words of "Immunity, Diplomatic immunity!" The cary cops pretended not to understand, lured 'em out and hauled 'em away for a short cooling ride. "Diplomatic immunity" is a special courtesy to help keep foreign diplomats out of minor difficulties, and even major troubles. As I read the law, a foreign diplomat can't even be sued for not paying his rent.

Griffin to Pay \$500 for Slander

A circuit court jury granted \$500 damages Friday to Mrs. Jennie Ware, 36, of 203 E. Main st., in her slander suit against M. J. "Mike" Griffin, veteran Madison tavernkeeper. Mrs. Ware had sought \$5,000 damages. She charged that Griffin had uttered "false and defamatory words" to her on Feb. 7, 1938, when he came into Griffin's former tavern at 123 E. Main st., in company with a friend, L. W. Taylor. The jury granted Mrs. Ware \$400 compensatory damages and \$100 punitive damages. Griffin's attorney, Lester Lee, had sought to prove that the tavernkeeper had never spoken to Mrs. Ware nor had notice that she came into his tavern on that date. The woman was represented by Atty. D. D. McIntyre.

Senators Ask Home, Credit Appropriation

An emergency bill appropriating \$49,500 a year for the Wisconsin Home and Farm Credit Administration was introduced in the senate Friday by Sens. Ben Gettelman (R., Milwaukee) and Philip E. Nelson (P., Maple). The amount sought for the administration, whose duties are to assist needy farmers, home owners, and others in obtaining credit facilities and to cooperate with the federal government in accomplishing these ends, is \$10,500 a year less than the amount received during the present biennium. The agency had requested \$33,000 a year for the coming biennium, but Gov. Heil failed to recommend any appropriation for the agency in his budget message. Another appropriation bill was introduced by Sen. Oscar Paulson (P., LaCrosse) which seeks \$25,000 a year for experimental work for the development and improvement of the tobacco industry in Wisconsin.

Bill Would Let County Clerks License Cars

A proposal to turn over licensing of motor vehicles from the secretary of state to county clerks was submitted to the assembly Friday. It would provide also for issuance of license plates designating the home county of the car or truck owner. The counties would get 25 cents out of each fee for costs of license administration.

Replace NLRB With New 5-Man Body, AFL Asks

MIAMI, Fla.—(U.P.)—The American Federation of Labor executive council Friday added a new amendment to those which it already has proposed for revision of the national labor relations act. Pres. William Green announced the new amendment would increase the membership of the labor board from three to five. Other federation proposals have been introduced by Sen. David I. Walsh (D., Mass.). The amendment would mean termination of the present board and its replacement with a new five-member board.

Exam Cheaters Suspended at Butler University

INDIANAPOLIS, Ind.—(INS)—Charged with obtaining an advance copy of final examination questions, 23 Butler university students were punished Friday. Two students who obtained the questions from a brief case left in Prof. Roy M. Robbins' American history classroom were suspended, one for a full year and the other for one semester. A third was placed on probation for one year. The others were "flunked" in the semester's work.

SHULLSBURG—The Lafayette county board has announced a raise in burial fees of destitute persons from \$75 to \$100. Russia plans several new air lines.

SAUK CITY—Funeral services for Mrs. Robert Homberger, 82, Sauk City, who died at her home Thursday, will be held at 1:30 p. m. Sunday from the home and at 2 p. m. from the Reform church. A son, Walter C. 306 S. Bassett st., Madison, three other sons, and a daughter survive.

Thomas Rudesill Appointment Wins Council Approval

Appointment of Thomas Rudesill, plant manager of Scanlan-Morris co., as a member of the board of personnel was approved by the common council Friday night. Rudesill succeeds Paul O. Winner, resigned. The park commission recommended that the city purchase from 12 to 25 acres of land in Madison Square on E. Johnson st. for a major playgrounds. The request was referred to the city property and finance committees. The council adopted the salary schedule for the department heads whose terms expire the third Tuesday in April. Only three adjustments were made. Purchasing Agent B. L. Gill was boosted from \$2,400 to \$2,500, plus \$300 car allowance; City Clerk A. W. Bares from \$2,900 to \$3,100 and City Assessor John Stock from \$3,000 to \$3,100, plus \$300 for car.

Nelson's Seaway Resolution Goes to 'Graveyard'

A resolution introduced in the Wisconsin senate Friday memorializing congress to enter into a treaty with Canada for construction of the St. Lawrence deep-waterway was referred to the committee on legislative procedure, the so-called "graveyard," despite objections of the author, Sen. Philip E. Nelson (P., Maple). Pointing out that all three political parties favor the proposed seaway, Nelson asked that his resolution be sent to the committee on state and local government for public hearing. Sen. E. J. Roethe (R., Fennimore), objected and Nelson's motion was lost, 15 to 12. Sen. Frances Yindra (D., Manitowish), joined the Progressive bloc in voting for Nelson's motion. Majority forces have insisted that all memorials to congress be referred to the committee on legislative procedure.

Stephen F. Chadwick, Seattle, Wash., national commander of the American Legion, will speak here and in Beloit March 17, it was announced at a meeting of the Madison Legion Thursday night.

Kin Reunited After 20 Years

MILWAUKEE—(U.P.)—Mrs. Maria Louise Hase, London, Eng., opera singer, and her brother, Victor Roberts, Milwaukee, were reunited today for the first time since 1919 when they parted in their native Germany. "We recognized one another immediately," Mrs. Hase said.
