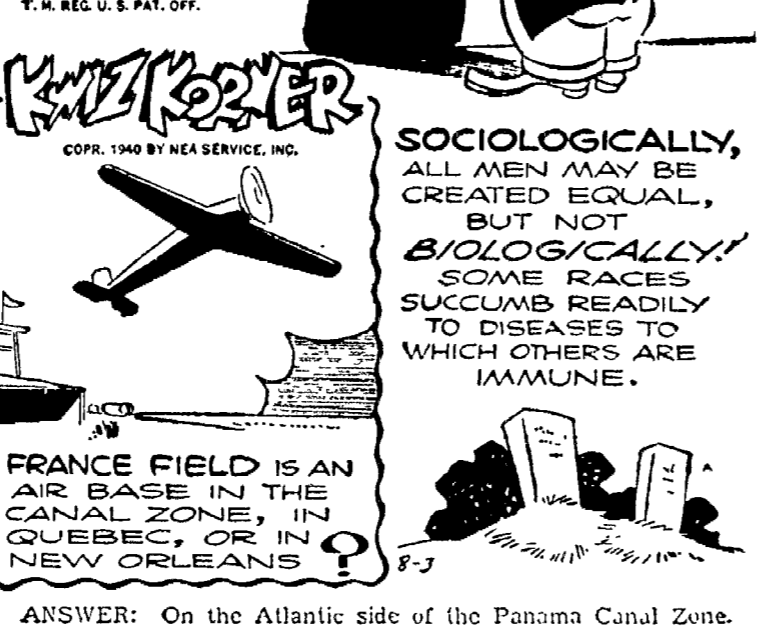

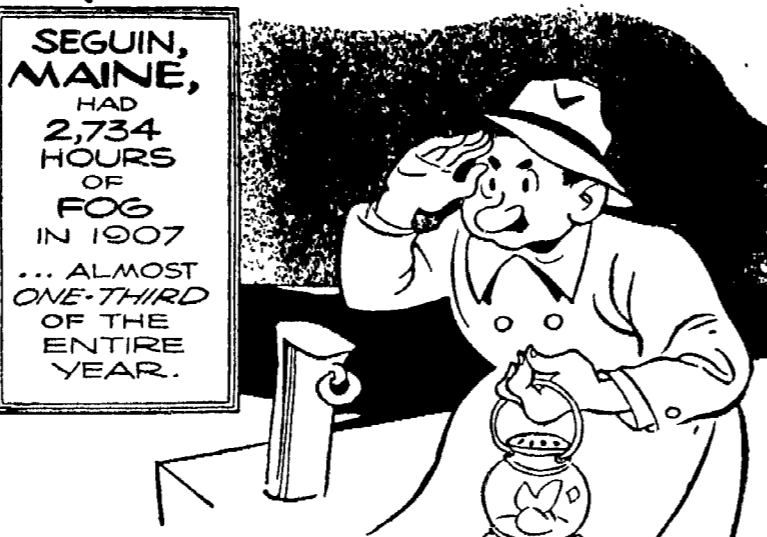

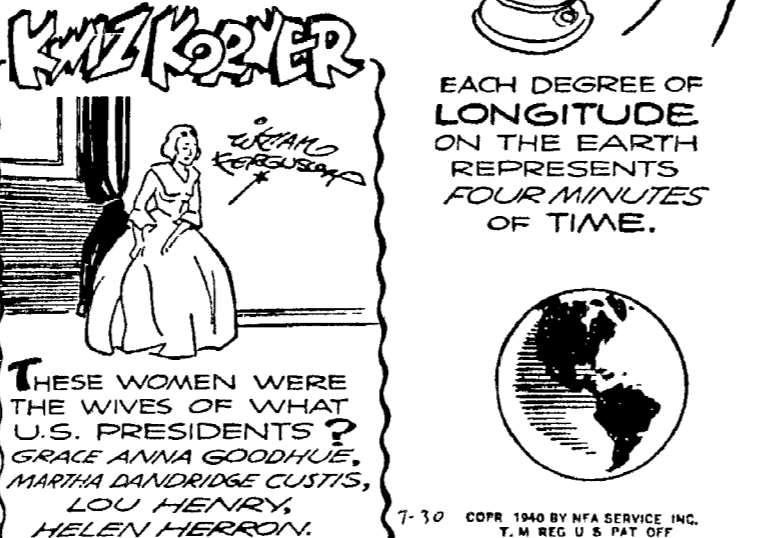


FRANCE FIELD IS AN AIR BASE IN THE CANAL ZONE, IN QUEBEC, OR IN NEW ORLEANS.

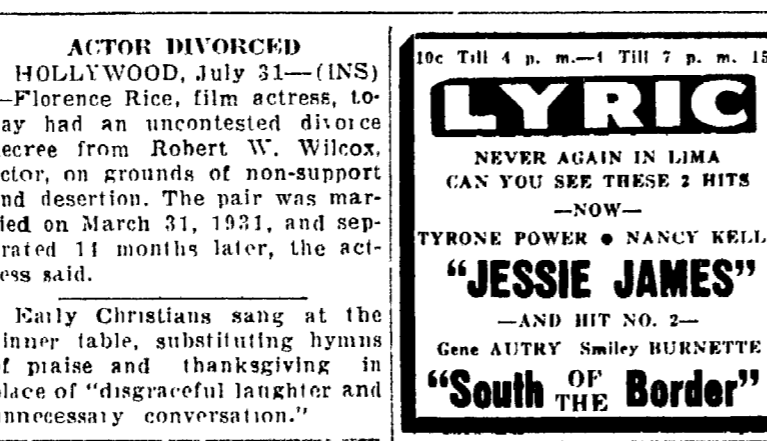

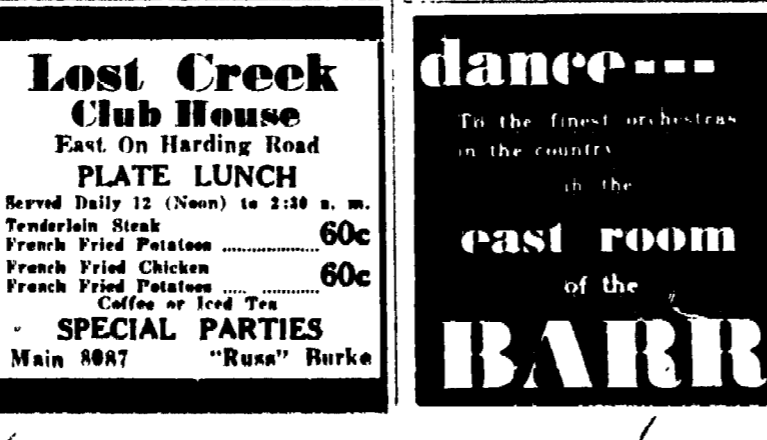

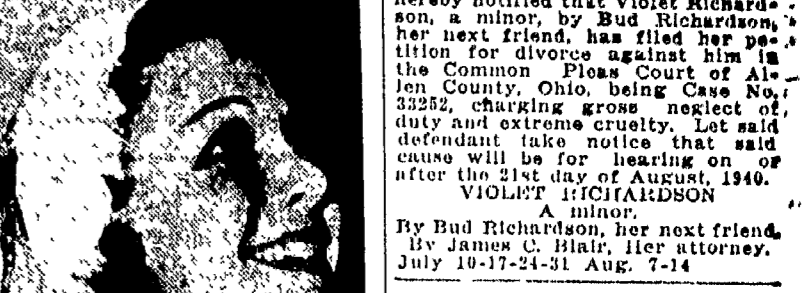
