IT'S TWO MONTHS, \$50 FOR BLASPHEMY, OLD DELAWARE LAW PROVIDES

WILMINGTON, Del., Aug. 23 (UP)—When misfortune befalls the legal-wise resident of Delaware, he counts 10, takes a deep breath, and exclaims in effect: "Oh, mercy me! Isn't that just too exasperating?"

At least, he doesn't say the naughty words. Not the Delawarean who knows his law and remembers that well-rounded, blue-blazing blasphemy can result in solitary confinement and a \$50 fine.

Section 2520 of the Delaware Penal Code reads: "Whoever shall be guilty of blasphemy shall be deemed guilty of a misdemeanor and shall be fined not exceeding \$50, shall be imprisoned in solitary confinement for not more than two months and may in the discretion of the court be held to surety of the peace and good behavior for one year after his discharge from prison."

HUNTS MERCURY IN WHEAT FIELDS

Chicagoan Will Search For Packet That Sunk 75 Years Ago

OMAHA, Neb., Aug. 23 (UP)—Frak P. Blair, Chicago, treasure hunter, is in Nebraska seeking information regarding the river packet Bertrand, which sank near De Soto, Neb., almost 75 years ago with a cargo of mercury said to be valued at \$800,000.

Blair, encouraged by information received from pioneers regarding the boat's disappearance, said he is willing to spend some money on the hunt and is sending to Chicago for a magnetic balance machine, which reportedly locates anything within 1,000 feet.

Blair said the magnetic balance apparatus rental cost usually was \$200 a day, but the owner had agreed to a much smaller fee, plus a percentage of whatever Blair might salvage.

Blair said he had found four old timers who agreed that the bulk lies within a fairly small area in a certain wheatfield which he refused to describe.

He recently returned from Florida, where he reported finding another boat that sank in 1865. He salvaged some whisky and sold it for as high as a dollar a drink.

Blair said the Bertrand had whisky aboard it was a violation of a federal law which prohibited taking whisky into the Indian territory.

OTHERS LOST NEARBY Blair says some three hundred boats were lost on the Missouri river, three of them in the vicinity of Blair and De Soto. First was the Bertrand; about three weeks later the Cora sank a short dis-

tant away; and in 1869 the Benton sank not far from the present site of the Blair bridge.
