Joanne Jackson Christens 'Flag' Vilas Zoo Deer Steps From Pulitzer Novel

"Flag," an American white-tailed deer, has stepped from the pages of Marjorie Kinnan Rawlings' famous novel "The Yearlings," to become part of Vilas park zoo.

One of the most appealing characters of the book by the former University of Wisconsin student and Pulitzer prize winner, "Flag" entered the heart of Joanne Jackson, 1901 Adams st., when she read the novel.

She lived through the book, reading of Jody, the 12-year-old Florida backwoods boy who took the fawn to raise.

When a new fawn was born at the zoo, Joanne heard of it. She lives near the park and all her life has been a regular visitor to the zoo, particularly fond of all baby animals.

She asked Director Fred Winkelmann to name a tiny animal "Flag," and he got it in the book. Winkelmann consented.

Mrs. Rawlings will be in Madison Oct. 8 to speak in the Memorial Union under the auspices of the Wisconsin Alumni club of Madison. Joanne hopes to meet her then, and to tell her of Madison's "Flag."

The famous author will turn over all proceeds from her appearance here to a scholarship fund, and will pay her own expenses and donate her speaker's fee.
