CHILE'S DESTINY LIES WITH U. S., SAYS ARTIST IN HIS CONCERT HERE

Young American students visiting South America have done much to wake up the people of that continent to what North Americans are really like.

So reports the distinguished Chilean pianist, Claudio Arrau, who appeared in concert Tuesday night at South high school auditorium under the sponsorship of the Northwest Civic Music-ssn.

A capacity audience heard the concert. "Many American students are now living in Chilean homes while they study Spanish or economic conditions in Latin-America," Arrau said.

Now, thru these students and the artists who are coming to South America from the north in constantly increasing numbers, we have come to appreciate what a great cultural center the United States is.

"Ten years ago, it was customary for well-to-do Chileans, as well as other South Americans, to send their children to Europe to complete their education.

Now we realize that our destiny—the destiny of all South America—rests with the United States. Our very differences are greater than our differences, and our differences are of the sort that will enable us to benefit each other."

Arrau said that in the United States, people have a more educated understanding of music.

GUADALCANAL, Jan. 3.—(Delayed) — (AP) — An encouraging sign was seen here today when a number of Japanese soldiers surrendered voluntarily in response to a broadcast over a loudspeaker from the American lines.

They were the first Japanese on Guadalcanal to give themselves up without compulsion and discredit the legend that all Japanese are ready to fight until death for emperor and country.

These hungry, sick soldiers were definitely discouraged and tired of fighting. They gladly accepted American offers to give them hot cooked rice, cigars and good treatment and came in with their hands in the air.

"I was sure I would die," one of the prisoners said thru an interpreter. "There was no hope. They have promised us reinforcements and airplanes day after day, but these promises were never kept. My feelings as a true Japanese soldier were gone."

"I didn't want to be a Japanese any more — I wanted to be an American. When I heard the voice from the Americans promising good food and good treatment, I came in."

This prisoner was Private Akiyoshi Hasamoto, 23, of Fukuoka in southern Japan. He said many other Japanese soldiers felt as he did about the war and expressed the belief many others would surrender in response to broadcasts in Japanese and pamphlets written in Japanese.

Hasamoto said that if Guadalcanal is a sample, he doesn't think Japan will win the war.
