## STEEL PLANT CLOSED BY WILDCAT STRIKE

**COLUMBUS, O., Jan. 7.—(INS)**—Federal representatives were expected to arrive in Columbus today to attempt settlement of a "wildcat" strike staged because of a wage dispute by workers of the Columbus plant of the Ohio Malleable Iron Co. Ward D. Walcott, field representative of the United Steelworkers Union (CIO), said the federal men were expected since the plant is "almost entirely" manufacturing war material.

Meanwhile production at the plant was at a standstill because approximately 350 of the plant's 450 employees resigned away from their jobs, according to a company spokesman.

Howard Porter, district director of the union, said a supplemental agreement covering an expired contract had been reached but the union's international and district offices refused to approve it because it conflicted with some of the union's international policies.
