Receiver to Run Bankrupt Firm

Awaiting Trustee Appointment

The Portage Wholesale Co. will continue to operate under direction of Receiver Bert Goetz until a trustee in bankruptcy is appointed, Federal Judge Patrick T. Stone said Friday.

Stone ordered the company into bankruptcy late Thursday when it defaulted on a \$150,000 payment due Thursday under an approved plan for settlement with creditors under the bankruptcy act.

Payment Forfeited

It also ordered that \$25,000 already paid into court as part of the \$175,000 settlement figure be forfeited to the bankrupt estate.

Represented in three different checks, the \$150,000 still due was "present" in court Thursday, but was not delivered.

Att. Abe Skolnik, Milwaukee, representing interests furnishing part of the settlement money, asked postponement pending arrangement for security, but Stone refused further delay when Nathan Ruppa, Milwaukee attorney representing the debtor firm, failed to appear at the hearing.
