JURY RETURNS DAMAGE VERDICT

\$315,100.91 Must Be Paid By

PITTSBURGH, March 24--(AP)

A verdict of \$315,100.91 was awarded here by a federal jury in

a unique double damage suit against 41 Pittsburgh electrical contractors, 12 firms and a trade association to recover losses on federal public works projects.

Attorney Morris Marcus, who filed the suit as a taxpayer, had asked for \$253,276.94 damages and \$112,000 in penalties claiming the defendants defrauded the government thru collusive bidding on 48

ment thru collusive bidding on 48 projects. Under a law of 1863 which permits a taxpayer to seek recovery of double the losses incurred by the government as the result of fraud. Marcus must split the verdict evenly with the government.

The verdict, reached after a

day's deliberation, set \$203,100,91 as damages and \$112,000 in penalties for the separate offenses.

The suit, which had been on trial 61 days, stemmed from a federal grand jury inquiry into building
